Dear Mr. President,

We write to request support of Florida Governor Ron DeSantis' request for a pre-landfall Emergency Declaration for the State of Florida as a result of potential tropical cyclone nine beginning on September 23, 2024, and continuing.

On September 23, 2024, Florida Governor Ron DeSantis declared a state of emergency in 41 Florida counties. On September 24, 2024, he expanded the declaration to 61 counties. Based on updated forecasts and modeling, the Governor is specifically requesting debris removal and emergency protective measures (Categories A and B), including direct federal assistance under the Public Assistance program for Alachua, Bay, Bradford, Calhoun, Charlotte, Citrus, Collier, Columbia, Dixie, Escambia, Franklin, Gadsden, Gilchrist, Gulf, Hamilton, Hernando, Hillsborough, Holmes, Jackson, Jefferson, Lafayette, Lee, Leon, Levy, Liberty, Madison, Manatee, Marion, Monroe, Okaloosa, Pasco, Pinellas, Santa Rosa, Sarasota, Sumter, Suwannee, Taylor, Union, Wakulla, Walton, and Washington Counties (41).

We urge consideration of the pre-landfall emergency declaration to enable the state to respond to expected heavy winds and rain, flooding, storm surge, and tornado activity. Many of the counties projected to be impacted by the storm are currently recovering from Hurricane Debby which hit Florida just last month. Federal resources will be necessary to augment the state funds available to respond to areas impacted by this storm.

We respectfully ask, within all applicable rules and regulation, that you urgently review and respond to the State of Florida's request and issue the request. We also ask that you expedite any additional requests for assistance the state may subsequently submit. Thank you for your attention to this matter.




